**THE QUANTITY OF VESSEL 'O.B.Q IN SHIP'S CARGO TANKS BEFORE LOADING AS MEASURED BY SHIP'S OFFICER AND ATLAS SURVEYOR WAS 23.295 M3 NON LIQUID.ALL RESPONSIBILITY AND CONSEQUENCES FOR THE AFFECT AND IMPACT ON THE QUALITY AND TEMPERATURE OF BITUMEN IN THE SHIP TANKS AFTER COMPLETION OF LOADING DUE TO THE PRESENCE OF O.B.Q IN THE CARGO TANKS OF M.T RMS 1 ARE RELATED TO THE MASTER OF M.T RMS 1 AND THE JEY OIL REFINING COMPANY WILL NOT ACCEPT ANY CLAIM AND PROTEST ON THE QUALITY AND TEMPERATURE OF THE BITUMEN AFTER COMPLETION OF LOADING.**

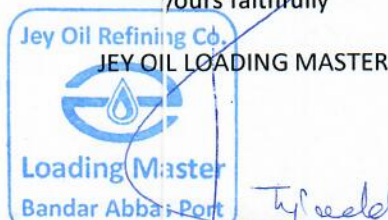
